Engagement Programs: In the past year, we have added 2 engagement choirs at Title 1 schools and we are in the planning stages to launch 2 additional programs in Spring 2018, totaling 7 projected engagement choirs by the end of the school year.

Between August 2016 and September 2017, over 100 girls sang with us in our engagement program. All of our singers, from our River Rd location and our engagement sites, participate in the annual Sounds of Winter and Sounds of Spring concerts, and are encouraged to attend our members-only camp over the summer. The modest cost of the engagement program tuition opens the opportunity for all girls to participate in the TGC; girls from the main location sing next to and build relationships with girls from underserved areas, eliminating racial and financial barriers and cultivating compassion.

Classroom Support and Beyond

Between August 2016 and September 2017, TGC staff visited 1400 students in 32 schools to support classroom music teachers. We conducted 15 additional site visits in the form of school-specific open houses or school assemblies to expose 800 additional students to our organization. We continue to strategically offer support year-round by providing clinics before school concerts and piano accompanying resources, all free of charge.

In August 2017, we held our 4th annual Choral Music Reading Session (a workshop to provide repertoire and programming resources) for music teachers, and 20 teachers attended, our highest attendance to date.

Young Women's Festival

In April 2017, we organized and hosted the first annual Young Womens Festival, a high-quality musical opportunity for high school young women who were nominated by their teacher. This festival came to be as a direct result of requests from Tucson's high school choir teachers. Teachers from 12 high schools nominated over 100 young women, 80 were accepted, and 56 participated.

Results

In addition to carefully tracking data, holding regular staff meetings to evaluate and implement programs, and supervising all engagement program conductors, the TGC conducts a survey for all parents to gain insight on the actual impact our organization delivers. Out of 150 respondents, 93% of parents noticed an increase in their daughter's self-confidence, 78% noticed an increase in their daughter's sense of responsibility, and 95% expressed that their daughter made new social connections within the program during the 2016-2017 season. On September 2017 TGC was awarded the 2017 Copper Cactus for Non-Charitable Business sponsored by the Tucson Metro Chamber.
