Part III Statement of Program Accomplishments:

The COVID-19 pandemic removed the ability to make music in-person. To maintain a connection to participating singers and to sustain our ongoing commitment to music educators, we have been innovative in creating new ways to continue furthering our mission. Beginning in March 2020, instruction was moved to a digital format. Curriculum consists of musicianship lessons as well as composition and recording projects. The results of the recorded projects were compiled into virtual concerts, featuring pieces from all choirs showcasing the resilience and creativity of the TGC singers, alumnae, and staff. Engagement programs have shifted due to the various challenges that our communities experience. School partnerships include virtual choir rehearsals, and a shift to an instructional format that will be more engaging for virtual singers. To continue support for teachers, the TGC developed specific virtual content providing resources and professional development for music educators worldwide at no charge. All content aims to address practical and technology issues that teachers have been facing, and to continue fostering music as a creative outlet and provide a sense of connectivity to support the growth of young musicians. The TGC directly serves students primarily in Pima County, however, since the COVID-19 pandemic, some of the TGC programming is no longer limited to Tucson. The annual performing arts summer camp, alumnae choir, and professional development sessions have had participants from around the globe. When the COVID-19 pandemic greatly impacted the world of music, the TGC staff got busy being learners as well as leaders on how to keep communal singing alive, teaching virtual content, practical tech support, and innovating around community engagement. The TGC continues to expand partnerships with Pima and Oro Valley Parks and Rec that allow for the TGC singers to have a place to sing outside of the building during social distancing. Additionally, partnerships with school districts continue to be a focus while we adapt programming to ensure that there are no barriers to singers being able to participate in programming. As we continue to foster connections with organizations, professionals, and partners, the TGC staff and organization as a whole are better equipped to learn through listening and put ideas into action. Although much remains unknown, we know that music is an invaluable source of joy and connection for so many. The TGC remains committed to providing access and creating impact, even as we are facing the challenge of doing so in very different ways.
