Part III Line 4a - Statement of Program Accomplishments:

This year we have grown the organization to 240 girls from 35 zip codes and 83 schools.

This includes growing the Bumblebee choir for girls K-1st grade, and the expansion of the engagement choir programs across the Tucson valley.

Our engagement throughout the community has dramatically expanded. We have held no-cost professional development sessions for local music teachers, enhanced our alumnae engagement by having over 70 women participate in our 30th anniversary concert, collaborated with over 30 organizations in Tucson as well as groups in Washington, New Jersey, Italy, the Netherlands, Latvia, and South Korea. There were improvements made to the facility including a remodel of the main rehearsal hall and restroom facilities, the addition of a new scholarship for women pursuing a career in music education, and the creation of an internship for choral conductor students.

2016 also saw the recording and release of the second CD for the organization. This new CD had tracks from every choir from the Bumblebees to the Alumnae choir. This CD was part of the 30th anniversary celebration along with the large alumnae presence at the Sounds of Winter concert.
